FORM OF BANK GUARANTEE FOR ADVANCE PAYMENT

To
The KIOCL Limited.,

In consideration of KIOCL Limited (hereinafter referred to as "Company") agreeing to pay to M/s.....(hereinafter referred to as, "Contractor") a sum of Rs / Foreign Currency (Rupees / Foreign Currency only) as and by way of advance in terms of Order No..... dated..... (hereinafter referred to as "Contract") on production of Bank Guarantee by the Contractor for Rs/ Foreign Currency (Rupees / Foreign Currency only) we, (hereinafter referred to as "the Bank") do hereby covenant and agree with the Company as follows:

1. We hereby guarantee the payment to the Company the said advance of Rs/ Foreign Currency (Rupees/ Foreign Currency only) in the said Contract.

2. Notwithstanding anything contained hereunder, we hereby unconditionally and irrevocably undertake to pay to the Company to the extent of Rs. / Foreign Currency..... (Rupees / Foreign Currency..... only) without any demur merely on a demand from the Company stating that the amount claimed is due by way of loss or damage caused to or suffered or would be caused to or suffered by the Company by reason of breach by the said Contractor of any of the terms and conditions contained in the said Contract. Any such demand made on the Bank shall be conclusive as regards the amount due and payable by the Bank under this Guarantee. However, our liability under this Guarantee shall be restricted to an amount not exceeding Rs / Foreign Currency (Rupees / Foreign Currency..... only).

3. We (indicate the name of the bank) undertake to pay to the Company the amount so demanded notwithstanding any dispute or disputes raised by the Bidder and / or any suit or proceeding pending before any Court or Tribunal or Arbitrator or any other Authority relating thereto, our liability under this present being absolute and unequivocal.

The payment so made by us under this Guarantee shall be a valid discharge of our liability for payment there under and the Bidder shall have no claim against us for making such payment.

4. We.....(indicate the name of the Bank) further agree that the Guarantee herein contained shall remain in full force and effect during the period fromto....., that would be taken for the performance of the said Contract and that it shall continue to be enforceable till all the dues of the Company under or by virtue of the said Contract have been fully paid and its claims satisfied or discharged and till the Company certifies that the terms and conditions of the said Contract have been fully and properly carried out by the said Contractor and accordingly discharges this Guarantee.

Unless a demand or claim under this Guarantee is made on us in writing on or before(90 days from the date of expiry of the Bank Guarantee), we shall be discharged from all liability under this Guarantee thereafter.

5. We,further agree with the Company that the Company shall have the fullest liberty without our consent and without affecting in any manner our obligations hereunder to vary any of the terms and conditions of the said Contract or to extend time of performance by the said Contractor from time to time or to postpone for any time or from time to time exercise of any of the powers exercisable by the Company against the said Contractor and to forbear or enforce any of the terms and conditions relating to the said Contract and we shall not be relieved from our liability by reason of any such variation or extension being granted to the said Contractor or for any indulgence by the Company to the said Contractor or by any such matter or thing whatsoever which under the law relating to sureties would, but for this provision, have effect of so relieving us.
6. This Guarantee will not be discharged due to the change in the constitution of the Bank or the Supplier(s)/Contractor(s).
7. In order to give full effect to the Guarantee herein contained, you shall be entitled to act as if we were your principal debtors in respect of all your claims against the Contractor hereby guaranteed by us as aforesaid and we hereby expressly waive all our rights of suretyship and other rights, if any, which are in any way inconsistent with the above or any other provisions of

this Guarantee.

- 8. Further, we hereby certify that this guarantee is adequately stamped under the relevant State Stamp Act and any deficiency in execution of this Guarantee shall not have the effect of relieving us.
- 9. We..... also undertake not to revoke this Guarantee during its currency except with the previous consent of the Company in writing.
