#### **Item No. 7: Appointment of Shri. Binay Krushna Mahapatra (DIN: 09613777) as a Director of the Company**

Ministry of Steel, Government of India vide order No. 5/1/2021-BLA dated 24.08.2022, appointed Shri Binay Krushna Mahapatra (DIN: 09613777) as Director (Commercial) on the Board of the Company from the date of his assumption of charge of post i.e., 30.08.2022 till the date of his superannuation i.e., 31.05.2026, or until further orders, whichever is earlier.
